To help ensure the health and safety of our personnel, clients, and visitors, we ask that you **do not** enter our space if: (i) you have tested positive for or have experienced symptoms of COVID-19 in the past 10 days; (ii) you are currently subject to quarantine by any country, state or local rule; or (iii) you have had close contact or live with someone who has either tested positive for or has had symptoms of COVID-19 in the past 10 days. By coming to this office, you certify that you will comply with the above.

All visitors will be required to complete a health and exposure monitoring questionnaire prior to entering our office on the date of their visit. Visitors will not be permitted to enter our office unless they have completed our online OfficePass questionnaire. All visitors must comply with the firm's policies and protocols while in our offices including, but not limited to:

- Beginning September 30, 2021, all visitors who seek to enter our offices must be vaccinated. Also, effective March 14, 2022, all lawyers, staff and/or visitors to any U.S. office must have received a vaccine booster. Visitors will be required to affirm their fully vaccinated status in our online OfficePass questionnaire.
- Effective March 1, 2022, all fully vaccinated visitors will no longer be required to wear masks in our D.C. office. Building management has also lifted its mask mandate in the common areas including the lobby, elevators, corridors, and restrooms.
- Visitors should not enter the office and/or leave the office immediately if they feel ill.
- Visitors must be escorted at all times. Visitors should not enter any vacant conference rooms, offices or workspaces as those spaces may be designated for other personnel.

Effective August 18, 2021, it is the Firm's policy that only individuals who are **fully vaccinated** against COVID-19 (i.e., two weeks after you received your second Moderna or Pfizer vaccines, or two weeks after the Johnson & Johnson single dose vaccine) may come into the office to work. In addition, beginning February 11, 2022, it is the Firm's policy that you must have also received a **booster** against COVID-19.

By completing the **required Pre-Office Entry Form**, you are certifying that you are fully vaccinated and have received a booster. Gibson Dunn personnel and guests who are not fully vaccinated, including the booster, may not enter the office.

If you have been tested recently for COVID-19 as a result of a known or suspected direct exposure and are currently awaiting test results, please do not come into the office until a negative test result has been confirmed.

If you are experiencing any potentially COVID-related symptoms, or any change in your health whatsoever, or have recently been exposed to someone who has tested positive for COVID-19, please do not come into the office and participate in any scheduled meeting remotely via Zoom or teleconference.
